I have the honour to report that on 11/10/2025 at about 5:30 pm, my husband Md. Najir Ahamad aged about 49 yrs s/o late Md. Ibochouba of Keibung Wangma Thong Makhong sustained bullet injuries on his left ankle and feet being fired out by one Md. Firoz Khan aged about 45 yrs s/o Md. Mubin of Keibung Wangma Thong Makhong from his Double Barrel Gun while my husband was inside our house. Immediately, he was evacuated to the District Hospital, Thoubal for medical treatment. Further, he has been referred to RIMS Lamphel for further treatment.
