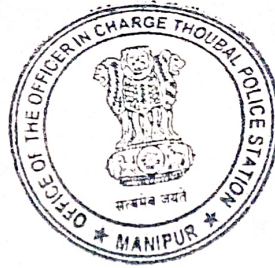

Subject : Report.

Sir,

I have the honour to report that on 16/10/2025 at about 8:40 pm, on receipt of information regarding playing of dice gambling (lagao) at Kiyam Wangmataba Makha Leikai area, I along with police team rushed to the said area. In that, around 50-60 unknown localities of Kiyam Wangmataba Makha Leikai were found playing dice gambling (lagao) at Kiyam Wangmataba Makha Leikai market shed. However, the unknown individuals who were playing of dice gambling (lagao) managed to escape from the spot as obstructed by some unknown drunkards while discharging police duties. Besides, they were also creating nuisance at the area under the influence of alcohol. They were highly intoxicated with aggressive and rudeness behavior disturbing the neighborhood and creating nuisance to the security personnel.

In the meantime, among unknown drunkards who obstructed police duty, one unknown person was detained at the spot. The said individual was identified as Thingujam Ibocha Singh aged about 55 yrs s/o late Th. Achou Singh of Kiyam Wangmataba Makha Leikai and on his verification, he admitted that he was directly involved in obstructing police duty. Hence, he was arrested at 09:30 pm from Kiyam Wangmataba Makha Leikai market shed. The arrested person Thingujam Ibocha Singh was medically examined at District Hospital, Thoubal where it was opined that he consumed alcohol (copy of the medical report is enclosed herewith for reference).

Some individuals among unknown others who were involved in obstructing police duty were also identified as (1) Thingujam Basanta Singh aged about 54 yrs s/o Th. Achou Singh of Kiyam Wangmataba Makha Leikai (2) Thingujam Ningthou Singh aged 31 yrs s/o Th. Tomba Singh of Kiyam Wangmataba Makha Leikai (3) Thingujam Gyaneshwor Singh @ Naotomba aged about 38 yrs s/o Th. Ibopishak Singh of Kiyam Wangmataba Makha Leikai and (4) Yumnam Jack Singh s/o Y. Sharat Singh of Kiyam Wangmataba Makha Leikai.

It is therefore, handed over the arrested person along with medical report for taking up necessary action in this regard
