Sir.

I have the honour to report that today i.e 18-10-2025 at about 8:35 pm, two police teams of Thoubal PS conducted drive against dice gambling (Lagao) at Thoubal Athokpam Makha Leikai Heikreng Makhong area. In that, some unknown persons found at the spot, formed an unruly mob and situation became volatile thereby started attacking towards our police teams. Our police team gave ample warning to disperse the unruly mob. Intead of paying any heed to the police warning, the unruly mob became more violent and continued to attack police teams by pelting stones. Having no alternative option at the moment, the police team fired three rounds in the safe direction and escaped from scene. Later on, the situation was brought under controlled with help of additional police teams at about 8:55 pm. In the said violent attack, one police vehicle Maruti Gypsy bearing regn. no. MN01K 5420 allotted to Thoubal PS was damaged on its hood.

It is therefore, requested to take necessary action in this regard.
