I have the honour to report that today i.e. 27-10-2025 at around 5:30 pm, while my elder brother namely Singham Naocha Singh (50) yrs S/o S. Tompishak Singh of Wangkhem Mamang Leikai was riding one Honda Activa bearing registration No. MN01AZ4653 towards Thoubal side coming from Imphal side along NH 102 at Thoubal Haokha near NRL Oil dashed by one unknown four wheeler car which was coming from same direction.
