12. First Information contents:

Today i.e. 23rd August, 2025 at @ 01.50 PM, I came across a viral post on social media uploaded by one Facebook handler namely "Pramot Singh" who has 30K followers. The Facebook post of "Pramot Singh", dated 22/08/2025, is reproduced as follows, "Biharda bihar nupi louraga or hinduda mayum pallaga islam onthokpa, assam dasu, rajasthan dasu, pangl, haigera, bangal haigera, mohamadan haigera pullap punsinlaga converted hindusingse MUSLIM kowi makhoi apumbagi target na Kafir loisinba. Sigumba politician singi ngahak ngahakki gazzet phajet bakwas sinani ngasi thokliba irang singse."

The literal English translation of the viral post is: **"In Bihar, Hindu girls are being married off and families are being converted to Islam. The same has happened in Assam, Rajasthan, Bengal, and with the Muslims (Pangals). Many converted Hindus have now become Muslims, and all their targets are the so-called 'Kafirs'. Meanwhile, some politicians are continuously spreading false and useless narratives through gazette publications. Such nonsense should not mislead the people."**

The viral Facebook post directly threatens and incites hatred between different communities. Circulating such hate message in social media misleads different communities which promotes hatred enmity, revenge and retaliation at this juncture where the restoration of peace is being started in Manipur. Moreover, transmitting such hate message provokes general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. As such, the above-mentioned Facebook post of "Pramot Singh" having more than 30K followers create fear and alarm to the general public, or to any section of public, whereby any person may be induced to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 293(08)2025 IPS U/s 196(1)(a)(b)/353 (1)(b)(c)(2)/61(2) BNS has been registered against the Facebook user namely Pramot Singh for investigation.
