I have the honour to state the following few lines for your kind perusal and further necessary action to register a regular FIR.

The brief fact of the case is that on 02/11/2024, the complainant namely DP Aaaquib aged about 34 years S/O (L) DP Abdul Haque of Lilong Haoreibi Makha Leikai, PO & PS-Lilong, Thoubal District, lodged a written report to OC-Imphal PS stating that in the month of August, 2024 one individual namely Md. Abdullah Makakmayum (48) yrs, S/o Makakmayum Abdul Manap of Mayang Imphal Bengoon Maning, P.O/P.S:-Mayang Imphal, Imphal West District, Manipur serving as Multi-Tasking Staff (MTS) Mail Branch, posted at Imphal Post Office, Babupara along with one Md Yahiya Khan @ Sanatomba aged about 34 years, S/o Md. Apabi of Hangoon Makha Leikai Sekmaijing, P.S-Hiyanglam, Kakching District, Manipur, Assistant Branch Post Office posted at Salungpham Branch Office, Wangjing Sub-Office took a sum of Rs 19,60,000/- (Nineteen lakhs and sixty thousand) only at the GPO Imphal to give appointment only for the post of MTS/BPM at GPO, Imphal. However, they fail to give the appointment only after taking the money. Despite he repeatedly reminded to pay back the same amount of rupees but he seldom listens to, rather they had challenged to the complainant. Surprisingly, in the month of October 2024 complainant visited at their residence and it was learnt that they already fled away from their residence. Hectic efforts have been made to trace out them but in vain and their mobile nos. 8119939179 (Md. Yahiya Khan), 9612537251 (Md. Abdullah) respectively are not attained till date. Hence the case and conducted an enquiry.

During the course of enquiry, examined the complainant very carefully and minutely. He disclosed that Md. Abdullah Makakmayum (48) yrs, S/o Makakmayum Abdul Manap of Mayang Imphal Bengoon Maning is serving as Multi-Tasking Staff (MTS) Mail Branch, posted at Imphal Post Office, Babupara and Md Yahiya Khan @ Sanatomba aged about 34 years, S/o Md. Apabi of Hangoon Makha Leikai Sekmaijing is serving as Assistant Branch Post Office posted at Salungpham Branch Office, Wangjing Sub-Office. They all have known each other. They inform/told to the complainant that there is a recruitment of MTS/BPM of the General Post Office (GPO), Imphal. Further told them to arranged money for the appointment of MTS/BPM. So, the complainant and his cousin brother have arranged Rs. 19,60,000/- and given the same amount to the above mentioned two persons for the appointment of MTS/BPM. The complainant also disclosed that he has a Video clips, in which Md Yahiya Khan @ Sanatomba stated that he have taken the amount and given to Md. Abdullah Makakmayum. During further course of enquiry, visited GPO for examination of Md. Abdullah Makakmayum (48) yrs, S/o Makakmayum Abdul Manap of Mayang Imphal Bengoon Maning. But he was absent. Further

visited at resident of Md Yahiya Khan @ Sanatomba aged about 34 years, S/o Md. Apabi of Hangoon Makha Leikai Sekmaijing for examination but he was not found at his resident. On Perusal of the Interim bail Objection report, the Hon'ble Judge has passed an order as stands vacated on date 11<sup>th</sup> November, 2024, vide Cril. Mics. (AB) Case No. 68 of 2024, Ref: G.D. Entry No. 14/IPS /2024 of Imphal PS.

Further, received interim bail of Yahiya khan @ Sanatomba aged about 34 S/O Md. Abdul Satar, a resident of Hangoon Makha Leikai, Sekmaijing, PS:- Hiyanglam PO:- Mayang Imphal, Kakching District from the Hon'ble Court of the Sessipn Judge, Thoubal, Manipur under Cril. Misc. (A.B) Case No. 64 of 2024 dated 30/11/2024. Accordingly, submitted a bail objection report to the Hon'ble Court. On Perusal of the Interim bail Objection report, the Hon'ble Judge has passed an order that the interim bail granted to the petitioner on 30/11/2024 is hereby rejected under vide Cril. Misc. (AB) Case No. 64 of 2024, dated 16/12/2024. As such a prima facie has been made out against the alleged accused persons namely Md. Abdullah aged about 49 years S/O Md. Abdul Manan of Mayang Imphal Bengoon Maning Leikai, Imphal West and Yahiya khan @ Sanatomba aged about 34 S/O Md. Abdul Satar, a resident of Hangoon Makha Leikai, Sekmaijing, PS:- Hiyanglam PO:- Mayang Imphal, Kakching District.


In view of the above facts and circumstances, it is requested to register a regular case in the interest of natural justice at the earliest.
