Sir,

I have the honour to state that today i.e. 30/08/2025 at around 09:10 am, a reliable information was received regarding the presence of some miscreants in and around ISBT area, Imphal East with a view to commit prejudicial activities i.e., transportation of arms and ammunitions. Based on the information and authorization of the authority, a team of CDO-IW led by Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW, assisted by Inspt Gunachandra Chanam, OC-CDO-IW, myself under the command of Shri. Rojit Irom, MPS, Addl. SP(LO),IW i/c Addl. SP(Ops),IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the ISBT area and conducted intensive search operation. During the operation, one Baleno car dark grey in color, was seen coming out towards the western gate of ISBT. The said car was detained near the ISBT western gate for checking. On checking the said car, one driver, one occupant and two luggage bags (i.e., one blue luggage bag on the back seat and another brown luggage bag in the trunk of the said car) were found.

During spot verification, the detainees identified themselves as (i) Laishram Tondomba Singh (27 yrs) S/o L. Subhachandra Singh of Ward no. 2, Wangjing Lamding Bazar, Thoubal District, Manipur (occupant of the said car) and (ii) Tourangbam Amarjit Meitei (20 yrs) @ Yaima s/o T. Praphulo Singh of Lamding Mamang Leikai, Thoubal District, Manipur (driver of the said car).

On preliminary verification of the 02 detainees namely, Laishram Tondomba Singh and Tourangbam Amarjit Meitei, they identified themselves as members of AT (Arambai Tengol) Unit-3, Wangjing. On enquiry, Laishram Tondomba Singh disclosed that the luggage's contained some arms and ammunitions and that he was informed by his commander namely Pilot that one Themrei (#8837246925) from Ukhrul District would be delivering 02(two) luggage bags from Ukhrul till ISBT, Imphal. He was also directed by his commander Pilot to receive the said luggage bags at ISBT area from Themrei and then to transport the 02 bags till their AT Camp located at Wangjing. He further disclosed that upon reaching ISBT, he was handed over the two luggage bags by Themrei and he then loaded the two bags inside the Baleno car. Tourangbam Amarjit Meitei disclosed that he came with Laishram Tondomba Singh to receive the said 02 luggage bags.

Thereafter, on opening the blue luggage bag which was kept at the back seat, the following articles were found:

- (i) 4 (four) nos. of HK33 Rifle bearing body nos. (a) 116221, (b) 091045, (c) 035642 and (d) 091513
- (ii) 1 (one) no. of M4A1 CARBINE gun,
- (iii) 13 (thirteen) nos. of empty magazine of HK33 Rifle and
- (iv) 3 (three) nos. of empty magazine of M4A1 CARBINE gun.

And, while opening the brown luggage bag which was kept in the trunk of the car, the following articles were found:

(i) 3 (three) nos. HK33 Rifle bearing body nos. (a) 072987, (b) 091315 and (c) 123196

(ii) 01(one) no. of M4A1 CARBINE gun marked with "US312144",

(iii) 2 (two) nos. of GLOCK .45 Auto Pistol bearing body nos. (a) TWV016 and (b) KYE467 respectively along with two magazines each,

(iv) 100 (one hundred) nos. of .45 ammunitions in four cases,

(v) 15 (fifteen) nos. of empty magazine HK33 Rifle and

(vi) 5 (five) nos. of empty magazine of M4A1 CARBINE gun.

Hence, Laishram Tondomba Singh and Tourangbam Amarjit Meitei were arrested at the spot i.e., **ISBT Western gate at 10:05 am and 10:10 am** respectively for transportation of foreign origin illegal arms and ammunitions.

Further, from the possession of Laishram Tondomba Singh, the following recovered items were seized by observing formalities at 10:30 am,: (i) One blue colour luggage bag containing the above illegal arms and ammunitions (ii) One brown colour luggage bag containing the above illegal arms and ammunitions (iii) one Redmi 14C 5G mobile handset along with one Airtel SIM card bearing mobile no. 8798102192 (as disclosed by him), (iv) one iPhone 11 mobile handset along with one Airtel SIM card bearing mobile no. 9856353866 (as disclosed by him), (v) one POCO C61 mobile handset along with one Airtel SIM card bearing mobile no. 8730952285 (as disclosed by him) and (vi) one grey wallet containing a sum of Rs. 1,030/- (rupees one thousand and thirty only) and one Aadhaar card bearing No. 8619 8103 6544.

And, from the possession of Tourangbam Amarjit Meitei, the following recovered articles were seized by observing formalities at 10:45 am, : (i) one iPhone 8 Plus mobile handset along with one Airtel SIM card bearing mobile no. 9362653167 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 3,400/- (rupees three thousand and four hundred only) and one Aadhaar card bearing no. 5496 5519 5917 & (iii) one Baleno car dark grey in colour bearing regd. no. MN01AX 0769 along with its key.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them for possession of illegal arms for the purpose of transnational weapons trafficking and for committing prejudicial activities.
