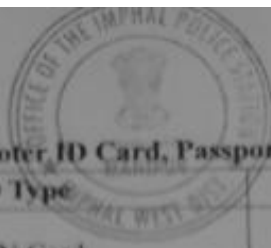

Sub: - Report.

Sir,

I have the honour to state that today i.e. 31/08/2025 at around 03:45 am, a reliable information was received regarding the presence of some miscreants in and around Sagolband Bijoy Govinda area, Imphal West District with a view to commit prejudicial activities i.e., possession/transportation of arms and ammunitions. Based on the information and permission/authorization of the authority, a team of CDO-IW led by Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW assisted by Inspt Gunachandra Chanam, OC-CDO-IW, Inspt. Anilchandra Mutum, Subedar L. Bikramjit Singh and myself under the command of Shri. Rojit from, MPS, Addl. SP(LO),IW i/c Addl. SP(Ops),IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to Sagolband Bijoy Govinda area and conducted intensive search operation. During the operation, one suspected person was detained at a house located at Sagolband Bijoy Govinda. On spot verification, he identified himself as Rajkumar Sidharth (33 yrs) @ Momo S/o. (L) RK. Kewalchand Singh of Sagolband Bijoy Govinda, Imphal West District, Manipur (who later on identified himself as the resident of the said house).

On preliminary verification, he disclosed that he is a member of Keishal Village Volunteer organization working under one Rameshor of Lairikyengbam Leikai. On further verification, he disclosed that he kept concealed some arms and ammunitions in his house for the said organization for the purpose of committing prejudicial activities. As pointed out by him the following articles were recovered:

- i) 01 (one) no. of AK Rifle bearing body no. 9188,
- ii) 02 (two) nos. of AK Ghatak Rifle bearing body nos. (a) 18LG0045 G-01 and (b) 19BG0029 G-01,
- iii) 01 (one) no. of INSAS Rifle marked with "B6668"
- iv) 02 (two) nos. of 7.62mm SLR bearing body nos. (a) T 7132 and (b) 16752426,
- v) 02 (two) nos. of 9mm Carbine bearing REG. nos. (a) 18251387 and (b) RR 8843 (modified butt),

- xxxii) 08 (eight) nos. of plate suspected to be used as BP (three in fiber and five in iron),
- xxxiii) 05 (five) nos. of camouflage helmet/Patka (suspected to be used as BP),
- xxxiv) 02 (two) nos. of helmet (one in blue and other in black colour) (suspected to be used as BP),
- xxxv) 12 (twelve) nos. of BP vest (eight in black, three in green and one in camouflage) and
- xxxvi) 02 (two) nos. of magazine pouch (one in black and other in camouflage).

Hence, he was arrested from the spot i.e., from his residence at 04:32 am by observing formalities.

Further, from his possession, the following recovered items were seized at the spot by observing formalities at 04:59 am : (i) the above recovered illegal arm and ammunitions, (ii) one iPhone 11 mobile handset along with one Airtel SIM card bearing mobile no. 8131916795 (as disclosed by him), (iii) one Nokia keypad mobile handset along with one Airtel SIM card bearing mobile no. 7085768280 (as disclosed by him) and (iii) one Aadhaar card bearing no. 3444 7060 8616.

Immediately, as a follow up action as disclosed by the arrestee, the said CDO-IW team rushed to the house of the above mentioned Rameshor after giving prior information to Imphal East District Police Control Room and as pointed out by the arrestee, Laishram Rameshor Meitei (44 yrs) S/o. L. Ranbir Meitei of Lairikyengbam Leikai Salan Leirak, Imphal East District, Manipur was detained from his residence. On spot verification, the detainee disclosed that he is the commander of Keishal Village Volunteer organization. He further disclosed that his associate namely one Brojendro from Top Awang Leikai kept concealed some arms and ammunitions for the said organization. He also disclosed that he was involved in transportation of illegal arms and ammunitions for the purpose of committing prejudicial activities.

Hence, he was arrested from the spot i.e., from his residence at 05:35 am by observing formalities.

Without losing much time, as a follow up action as disclosed by the arrestee namely Laishram Rameshor Meitei, the said CDO-IW team rushed to the house of Brojendro after giving prior information to Imphal East District Police Control Room and as pointed out by the arrestee (Laishram Rameshor Meitei), Athokpam Brojendro Singh (45 yrs) @ Mukil S/o. A. Tompapu Singh of Top Awang Leikai, Imphal East District, Manipur was detained from his residence. On spot verification, the detainee disclosed that he is a member of Keishal Village Volunteer organization and he kept concealed some arms and ammunitions at the river bank located near his residence for the purpose of committing prejudicial activities. As pointed out by him, the following articles were recovered:

- i) 01 (one) no. of modified .303 Rifle bearing body no. 12652 M mounted with a scope,
- ii) 02 (two) nos. of 7.56mm INSAS Rifle bearing body nos. (a) 18414067 and (b) 18531143,
- iii) 01 (one) no. of 7.62mm SLR bearing body no. Z2799,
- iv) 01 (one) no. of 7.62 LMG magazine,
- v) 09 (nine) nos. of 7.62 SLR magazine,
- vi) 01 (one) no. of INSAS LMG magazine,
- vii) 07 (seven) nos. of INSAS Rifle magazine,
- viii) 01 (one) no. of .303 Rifle magazine,
- ix) 04 (four) nos. of Rifle Sling and
- x) 02 (two) nos. of plastic bottle containing: (a) 82 (eighty two) nos. of AK ammunition, (b) 86 (eighty six) nos. of INSAS ammunition, (c) 44 (forty four) nos. of .303 ammunition, (d) 05 (five) nos. of empty case of 7.62 ammunition and (e) 01 (one) no. of empty case of INSAS ammunition.

Hence, he was arrested from the spot i.e., from his residence at 06:13 am by observing formalities.

Further, from his possession, the following recovered items were seized at the spot by observing formalities at 06:25 am : (i) the above recovered illegal arm and ammunitions and (ii) one Redmi 10 Prime mobile handset along with one Vodafone SIM card bearing mobile no. 8794752433 (as disclosed by him).

He further disclosed that he handed over one AK Rifle to his associate namely one Sachikanta from Top Awang Leikai.

Again, as a follow up action as disclosed by the arrestee, the said CDO-IW team rushed to the house of the above mentioned Sachikanta and as pointed out by the arrestee (Athokpam Brojendro Singh), Laishram Sachikanta Singh (25 yrs) @ Naathing S/o. L. Jadumani Singh of Top Awang Leikai, Imphal East District, Manipur was detained at his residence. On spot verification, the detainee disclosed that he is also a member of Keishal Village Volunteer organization and he kept concealed some arms and ammunitions in his bed room for the purpose of committing prejudicial activities which was handed over by Athokpam Brojendro Singh. As pointed out by him, the following articles were recovered:

- i) 01 (one) no. of AK Rifle bearing body no. 5155,
- ii) 03 (three) nos. of AK Rifle magazine,
- iii) 10 (ten) nos. of AK ammunition,
- iv) 35 (thirty five) nos. of INSAS ammunition,
- v) 23 (twenty three) nos. of 7.62mm ammunition,
- vi) 04 (four) nos. of .303 ammunition,
- vii) 05 (five) nos. of empty case of INSAS ammunition,
- viii) 03 (three) nos. of empty case of 7.62mm ammunition and
- ix) 07 (seven) nos. of empty case of .303 ammunition.

Hence, he was arrested from the spot i.e., from his residence at 06:32 am by observing formalities. Further, from his possession, the following recovered items were seized at the spot by observing formalities at 06:38 am: (i) the above recovered illegal arm and ammunitions and (ii) one Redmi Note 10 mobile handset along with one Jio SIM card bearing mobile no. 7005030664 (as disclosed by him) and (iii) one Aadhaar card bearing no. 2958 2671 4387.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them for possession/transportation of illegal arms and ammunitions for the purpose of committing prejudicial activities.
