Sir,

I have the honour to report that today i.e. the 24th September, 2025 at about 1:00 p.m. received a reliable information from our own source corroborated with the intelligence of 2/2 GP about the presence of some anti-social social elements suspected to be illegal arms smugglers at Moirangkhom area of Imphal-West District. Based on the said information and with the permission/authorization of the authority, a team of CDO/IE conducted a searched operation at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 2:00 p.m. after providing prior information to Imphal West District Police.

In that, one suspicious unknown person was detained for spot verification and checking at Moirangkhom Old Thumbuthong Makhong, Imphal West District. On checking the detainee body one mobile phone was found and recovered from his possession. On checking the carry bag of the detainee, one 9 mm Pistol loaded with one live round in the magazine containing inside a transparent plastic box were recovered from his possession. On verification, the detainee identified himself as one Kangiam Rakesh Singh (48 years) S/o (Late) K. Shyam Singh of Brahmapur Bamon Leikai, Mahabali Road, Promptat PS, Imphal East District. On further verification, the detainee stated that the above recovered pistol and ammunitions were handed over to him by one Mr. Bidyasagar from Bamon Kampu, Imphal-East in the month of August, 2025.

So, the detainee was arrested from the spot i.e. Moirangkhom old Thumbuthong Makhong near Waiting Shed, Imphal West District at 2:40 p.m. and seized; (i) one 9 mm Pistol loaded with one live round in the magazine, (ii) one mobile phone (VIVO Y21) bearing IMEI NO. 860301057566219 & 860301057566201 along with two SIM cards having phone nos. Airtel-6909967700 And Jio- 8131087782, (iii) One carry bag, off white in colour and (iv) one plastic transparent box from his possession at the spot i.e. i.e. Moirangkhom old Thumbuthong Makhong near Waiting Shed, Imphal West District at 2:45 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
