Sir,

With due respect, I have the honour to state the following few lines for your kind perusal and further necessary action to register a regular FIR.

The brief fact of the case is that on 28<sup>th</sup> Aug., 2025 one Chingakham Rebecca Chanu, aged about 45 years, W/o Leishangthem Raju Singh of Thangmeiband Polem Leikai, Imphal West District, Manipur lodged a complaint report with OC/Imphal-PS stating that in the year 2020, she invested an amount of RS. 3,00,000/- (Rupees three lakhs) only with "MAICHOU SERVICE" whose office is situated at Sagolband Meino Leirak, Imphal and run by Ronald Rajkumar, S/o R.K. Dorendro Singh of Sagolband Meino Leirak and Soubam Rohit Singh, S/o S. Kiran Singh of Sagolband Thingom Leikai, Imphal. At the time of investment, they assured her an interest rate of 8 % per month on the invested amount. Initially, they paid the assured interest for 10 months; only after which they abruptly discontinued the payment since December, 2020. Despite her repeated requests to refund the invested amount, they have failed to return till date. She visited their residence several time requesting repayments of the invested/capital amount but they refused and instead threatened with dire consequences by them and warned her not to come to their house. Now, they absconded from their houses and their current whereabouts are still not known. Their phones are switch off. Their acts clearly amount to cheating and criminal breach of trust. Hence, an inquiry has been conducted in this regard.

During the enquiry, the complainant was examined very carefully and minutely. Visited the house of the accused persons namely Ronald Rajkumar S/o R.K. Dorendro Singh of Sagolband Meino Leirak and Soubam Rohit Singh S/o S. Kiran Singh of Sagolband Thingom Leikai, Imphal. But the both accused were absent at their residence and they are not co-operating with the investigation. From the material evidences collected so far during the enquiry and examination of witnesses, it is highly required to register a regular case at the earliest to conduct a smooth investigation and to arrest the culprits.

It, is therefore, submitted this report for your kind perusal and further necessary action to register a regular FIR at the earliest.
