Complaint for Registration of FIR against Md. Ejas Ahmed and Associates for Extortion, Criminal Intimidation, and Forceful Taking of Vehicle

(Regd, No. AS26F-0870)

Respected Sir,

I most respectfully submit this complaint for registration of an PIR against the persons named below for committing serious cognizable offences involving extortion, intimidation, and illegal deprivation of property. The facts are as follows:

1. Victim:

Name: Mr. Fariddul Hasan

Father's name: Siddik Ali Ahmed

Address: Resident of Upper Luitpur, Kharghuli, Mamrup Metropolitian-781004,

Property Involved: Black Thar Vehicle bearing Registration No. AS26F0870

Accused Persons;

Accused No. 1: Md. Ejas Ahmed, aged about 28 years, S/o Md. Abdul Khalique, resident of Lilong Yangbi Leikai, P.O. & P.S. Lilong, Thoubal District, Manipur. Accused No. 2: Eight (08) other unknown individuals, armed with small firearms. identity to be ascertained during investigation.

Sequence of Events:

- 4. On 28th September, 2025, Mr. Fariddul Hasan along with two companions arrived in Imphal and checked into Hotel Magestic, Namdunlong, Khuman Lampak, near ISBT, Imphal East District. Their local contact, Md. Ejas Ahmed, who had previously resided in Karimgani, Assam, and was acquainted with Mr. Hasan, acted as host.
- 5. On the same day, at the instigation of Md. Ejas Ahmed, eight armed individuals wrongfully restrained and threatened Mr. Hasan and his companions. Under criminal intimidation and fear of life, they extorted a sum of Rs. 10,16,000/- (Rupees Ten Lakh Sixteen Thousand only) - of which Rs. 42,000/- was collected in cash and the remaining was extorted through electronic transfer into accounts belonging to the accused.
- 6. On 29th September, 2025 at about 9:30 p.m., the same group, led by Md. Ejas Ahmed, again accosted the victims. This time, they forcefully took possession of the Thar vehicle (Regd. No. AS26F0870, Black in colour). Prior to unlawfully taking away the vehicle, they compelled the victims under duress to:

* Record a false video declaration as if the vehicle was being surrendered towards

repayment of a borrowed loan.

* And sign multiple blank sheets of paper, which are evidently intended to be misused to fabricate documents against the victims.



7. Grave Nature of the Incident: The entire incident has caused grave loss and irreparable hardship to the victim and his companions. They were deprived of their lawful property, forced under arms and threat to part with large sums of money, and coerced to sign blank papers which may further be misused. The accused persons are a continuing threat to public order, safety, and security.

In light of the above facts and circumstances, I humbly request your good office to:

- a) Kindly register a formal First Information Report (FIR) under the above-mentioned provisions of the IPC and Arms Act;
- b) Conduct a thorough and impartial investigation into the matter;
- c) Recover the extorted money and the Black Thar Vehicle (AS26F0870)
- d) Arrest and prosecute all the accused persons in accordance with law.

I shall furnish further details, including transaction receipts, bank transfer records, hotel booking proof, and identification of the accused, as and when required by your office during investigation.
