

I am to submit herewith a report regarding a serious incident of physical assault that occurred on 27th September, 2025 at Netaji Subhash Chandra Bose Awasiya Vidyalaya (Boys' Hostel), Lilong.

It has been brought to notice that the Hostel Warden, Md. Ajimuddin, physically assaulted a group of hostel students inside the hostel premises. As per preliminary information gathered, a total of 15 students were subjected to severe beatings with a stick. The incident occurred between 10:40 p.m. to 11:30 p.m. on the said date, following which some students, out of fear, attempted to flee from the hostel campus byl1:30p.m. While doing so, they obstructed traffic on National Highway No. 102 near Lilong Bazar.

Local individuals in the highway later rescued the injured students and, with the assistance of other staff, escorted them back. The victims bore visible marks of injuries, causing great fear and unrest among the student community. The matter was verified by me on 28th September, 2025 in the presence of the Medical Officer, CHC Lilong; Resource Person (SMC); and local authorities. The students, witnesses, and affected parents have confirmed the incident. Photographic evidence and medical observations have also been recorded.

The act of physical assault and use of corporal punishment is a gross violation of the Educational Guidelines of the Department of Education (S), Manipur and cannot be condoned under any circumstance.

In view of the seriousness of the incident and to ensure the safety and well-being of the students, I request you to kindly register the matter under relevant legal provisions and take necessary action against the accused Warden.
