- Based on specific input about movement of 3 (three) cadres of UNLF, A column of Kasong COB of 24 Assam Rifles established a surveillance grid in General area Namlee.
- 2. Based on corroborated inputs from own sources and No 2 FID, DG ARFIU. It was established that the cadres are trying to sneak into Imphal valley by passing the above points and village areas.
- 3. An ambush was laid in general area Namlee on 15 Sept 2022 at 0600 hrs. At about 1900 hours, the party observed 3(three) persons moving suspiciously hence were immediately apprehended. On initial questioning, the individuals admitted that they were 3 (three) active cadres of UNLF who deserted their camp in Myanmar.
- 4. You are requested to lodge a report and do the necessary action please.
- 5. All 3 (three) apprehended cadres along with seizure memo, Handing/Taking over certificate and medical fitness certificate are enclosed herewith.
