On 15th November, 2023 a team of Kasom Khullen PS led by Marchang Wungmahai, OC Kasom Khullen-PS, conducted a survey on poppy cultivated areas in hill range near Chondan village and surrounding places and found that opium/poppy plants are illegally cultivated at some places north of Chongdan village settlement area under Kasom Khullen Sub-Division, PS-Kasom Khullen, Kamjong District. From own source, it was reported that the cultivators are from Chongdan village. A report on the survey was submitted to District Magistrate Kamjong, for issuing an order of Attachment and destruction of the opium/poppy cultivated land. Accordingly, District Magistrate Kamjong. Assigned Shri HL Jain, MCS, Addl. District Magistrate/SDO Kasom Khullen for Magisterial duty to issue an order for Attachment and Destruction u/s 48 ND&PS Act, 1985 and also destruction certificate. As such, the order for Attachment and Destruction u/s 48 ND&PS Act, 1985 was issued on 08/01/2024 by the aforementioned Executive Magistrate. A team led by OC/KKL-PS have destroyed the poppy plantations measuring around 20 acres on 10/01/2024 at the northern side of hill range near Chongdan Village.

Hence a case under FIR. No 1(01)2024 KKL-PS u/s 18(b)/46 ND&PS Act has been registered against the poppy cultivators on Sun-motto for investigation.
