First information report

1. Based on specified information of source regarding the movement of 4/5 armed cadres from moreh towards Khairpur in a white minivan one platoon under upper kourpax cco s/o 01/01/15 at MVCP in gen area road truck junction point 1692-KM-7012 way 031100 hrs to 031155 hours. At 031155 hours one suspected minivan was stopped by one MVCP team on being challenged by own team the four individuals who were sitting inside came out and were thoroughly searched. The search team while searching the minivan recovered following arms and ammunition (details are in para 3 below).
2. On the spot interrogation was carried out, the individual confessed that they the active cadres of 500 group (NSCN/IM) and KNO. The MVCP team after preliminary interrogation apprehended the following:
 - a) SS. Capt. S. Hopeson age 34 s/o S. Kothel village Thanai PS. Laitan Ukhrul District. Group NSCN (IM).
