Sir,

① Based on information provided by EW detachment at Chassad, Special operations were launched with strength of 01 officer and 15 other ranks under Maj AG patel in general area K. Asang Khullen from Kasong post of 44 Assam Rifle at 0300 hrs on 03 Dec 13,

② At approximately 06.15 hr on 03 Dec 13, the ambush party under Maj AG patel observed movement of three suspected persons on track K. Asang Khullen - Wanglu in general area K. Asang Khullen, on being challenged by Maj AG patel the suspected tried to run but were later overpowered, on search of the individuals following arms and ammunition were recovered from the possession, and they disclosed that they are active members of the banned outfit UNLF.
