FIRST INFORMATION REPORT

Sir,

1. The undernoted persons have been apprehended by Joint team of "A" Team, 11 PARA (SF) and "E" company of 17 Assam Rifle in area of border pillar 08 (old) and border pillar 09 (old) under Kamjong dist at 1100 hrs on 03 May 2019 and recovered arms and ammunition from the persons as given in para 6.
2. An input was received from 3 Corps Intelligence and Surveillance unit regarding infiltration of UGs from Gen area of border pillar 08 (old) and border pillar 09 (old). Based on the information a combined team of 11 PARA (SF) and 17 Assam Rifles was launched on 03 May 2019 at 2000 hrs.
3. During the surveillance from 0300 L onwards on 03 May 2019, suspected cadres were observed in the adjoining nallah. The ops party laid stops in different locations. On being challenged the individuals surrendered willingly and arms and ammunition were recovered from them.
4. On brief interrogation, all of them were found to be deserters from PREPAK KYKL and UNLI (ATOC) (g) (f).
