



SUBJ: REPORT

1. Based on reliable inputs received through own sources regarding desertion of Manipuri group cadres from Myanmar and their attempt to infiltrate from Myanmar into own territory through Gen area Namlee-Wanglee mkt, an operation was planned to intercept and apprehend the infiltration cadres. Multiple MVCPS/ambush columns were launched on foot tracks coming from Myanmar towards Namlee-Wanglee mkt to intercept the infiltrating cadres.
2. On 14 Jan 2024 at around 0300 hrs, the column at Wanglee mkt intercepted move of three suspected individuals moving on foot track from Myanmar towards Wanglee mkt.
3. Upon questioning the mov of the three suspected individuals during hours of darkness in inclement weather from Myanmar towards Wanglee mkt could not be justified. The three suspected apprehended individuals were apprehended at 0330hrs and were brought to COB Kasong for detailed questioning during which they revealed that they belonged to the banned outfit KYKL.
4. Details of apprehended individuals are as under:-
  - (i) Mr. Thongbam David Singh aged 21 years s/o Late. Jiten Singh r/o Nambol, Bishenpur, Manipur.
  - (ii) Mr. M Raj Singh age 23 years s/o Mr. Rajen r/o Kakching, Manipur.
  - (iii) Mr. K H Avinash age 19 years s/o Mr. Brojen r/o Kakching, Manipur.
5. You are requested to lodge an FIR in this regard and book the individual as per the requisite law.
