SUBJECT : APPREHENSION REPORT

1. On 14 Jun 2025, credible int. input was received from own sources regarding likely presence of VBIG cadre in general area Taret River. In response two columns were swiftly launched toward Taret River.
2. The columns after reaching the designated location were tactically deployed astride the river to cordon off the suspected infiltration route. During the search operation, at approx. 1900 hrs, the columns observed move of three suspicious individuals. Upon challenging, the suspicious individuals tried to escape but was physically over powered and apprehended by security force. Due to complete darkness, no videography of the incident was done.
3. Upon interrogation the individuals revealed that they belong to banned outfit of KYKL and KCP.
4. Details of apprehended individuals are as under:-
 - (i) **Mr. Bidyananda Shijagrumayam Rank- Pvt, Age- 25 Yrs, Address- Khurai Thongam Leikai, Imphal East, Faction- KYKL(Joined KYKL in Oct. 2024 and moved to Myanmar in Jan 2025)**
 - (ii) **Mr. Tonsana Moirangthem Rank- Cpl, Age- 27 Yrs, Address- Moirang Thamnapokpi, Bishnupur, Service- 3 Yrs, Faction-KYKL(Joined KYKL in 2022 and moved to Myanmar in Nov. 2024)**
 - (iii) **Mr. Omitkanta Nongmaithem, Rank- L/ Cpl Age- 27 Yrs, Address- Wangjing Lamding Bazaar, Khumanthem Leikai, Thoubal, Faction- KCP (joined KCP in Jul 2024 and earlier served in KYKL from 2017 to 2018)**
