Sub-Report

1. Based on specific input about movement of 4x Cadres of KYKL/PREPAK, a cdm of Kasang COB, 24 Assam Rifles established a surveillance Grid in Gen area Mekan and Nambashi.
2. Based on corroborated inputs from various sources, it was established that the Cadres are trying to sneak into Imphal valley by passing the points and village areas.
3. An Ambush was laid in area between Kashong - Nambashi on 27 Jul'20 at 1900h. At about 2100h, the party observed 4 pers moving suspiciously hence were imtdly apprehended. On questioning the individuals admitted that they were 4 active Cadres (1x PREPAK & 3x KYKL) who deserted their Camp in Myanmar.
