SUBJ : REPORT

1. Based on reliable inputs received from intelligence agencies regarding an individual trying to smuggle and sell a cache of arms and ammunition to some unknown individuals between Kamjong and Tengnoupal districts and further corroboration by own sources about a suspected Kenbo bike left unattended between Khoiripok and Mollen along NH 102A near Hongbei. A search operation was launched to search the area on 16 Jan 2024 along with a police team from Kasom Khullen PS.
2. The columns commenced search operation from Hongbei at 0600 hrs on 16 Jan 2024 and swept the area. At around 0745 hrs the search columns identified a suspected foreign origin Kenbo bike hidden in the foliage near Hongbei-Yaripok-Khoiripok road junction. On inspection by an explosive detector dog, the dog indicated presence of suspicious items.
3. On thorough search of the area, items as mentioned in the seizure memo were recovered at 0830 hrs during the search operation and handed over to Kasom Khullen Police Station for further investigation.
4. You are requested to lodge an FIR in this regard under the requisite section of the law.
