I have the honor to report you that today i.e 22-2-05 at about 3:15 pm I along with my team were conducting patrolling / checking and checking over the suspected persons at mentioned area. During checking we arrested 2 (two) NISCAI (in) cadres namely (1) Jackson Shangchiri (37) S/o Shingari Shangchiri of phuritan area District PS-unsub. (2) Apu Shadary (a) Ashay (23) S/o Lighton Shadary of Kangry Naxal area District. They were arrested from Marhounam P.S. On body search of Jackson Shangchiri (37), one A.K. 56 Rifle having NO-22824/56-1-26122824 along with one magazine along with 30 nos of AK-56 amms. was seized from the possession of Jackson Shangchiri and 1 (one) 9mm pistol (Remco) USA made in (U.S.A) having NO. BCR-566-446 Type - M9A1. along with two magazine and 27 nos of 9mm amms. were seized from the possession of Apu Shadary. On further Examination they disclosed that they are active member of NISCAI (in) and joined in the year of 2002 of which through one H.O. of NISCAI (in)

30. The two arrested accused persons along with the seized items have been handed over to you for further necessary legal action against them.
