I the Headman of Hongbi village would like to draw your kind attention and necessary action on the above mentioned Subject that Chongdan village led by ① S. Ngachonmi ② H. Athot (VA Chongdan) ③ S. Ngathingmi (VA Chongdan) ④ S. Hongngam ⑤ Mc. Yaomi (Secn Chongdan) ⑥ Mc. Ngaraomi ⑦ S. Shangmithang ⑧ S. Ngaraokhui ⑨ Mc. Nongringam I am water supply PHC implant ⑩ S. Maluiching (Ex-Serviceman Nagakeng next Ruisiphung village) ⑪ S. Lixison EX-Serviceman ⑫ S. Sophyo ⑬ S. Wangchan (Ex-ray department Ukhrul) come along with 30 people with 60 Arms (S&W, 303 Rifle Bomb) and attacked early this morning at 4 am (07-08-2009) Set fire and burnt down completely 2 houses and church building. Mr S. Yaomi of Hongbi was shoot at the left leg and beaten up seriously and left nearly dead of the down stream

Therefore, I request you to take up the stern action and judge in your judicial law and custody. I shall be grateful to your kind Act,
