As per SP/KJG vide order No. 1-B/17(ND&PS)/SP(KJG)/051 dated 4th January 2022, a combined team of Kamjong District Police, NAB, 6th Bn. MR and Forest Dept. carried out destruction of illicit poppy cultivation at T. Natyang Hill Range which falls under the jurisdiction of Kasom Khullen – PS on 9th January 2022 from 9:30 am – 1:30 pm by the order of SDC/Kasom Block who furnished attachment and destruction order of illicit poppy cultivation in the said area u/s 48 ND&PS Act, 1985 (as amended). 14 acres of illicit poppy cultivating areas were destroyed which is expected to yield 140 kgs i.e. 10 kgs/acres of opium. The location of the cultivated areas were located at T. Natyang Village Hill range. As per customary law the Chief of T. Natyang Village namely Mr. H. Ngamkhair is the sole owner of his village's land. There is no Patta system in the area under cultivation. Thus, some poppy pods were seized for inducing evidence if required in the Court and for further legal action.

Hence, a suo moto case under FIR No. 4(1)2022 KKL-PS, U/s 18 (b) ND&PS Act was registered for investigation.
