Subject - Report U/s 57 ND & PS Act

Sir,

I have the honour to report that, today 26/02/2021 at about 3.20 a.m., an information was received by me that heroin/brown sugar manufacturing was taking place at the eastern hill side of T. Natyang Village. Accordingly, the information was recorded in writing and a copy of the same was forwarded to Officer-In-Charge Kasom Khullen Police Station, for further necessary action. Due to the possibility of the contraband manufacturing unit and the processing material and chemicals being shifted to other location, a combined team of 26 Assam Rifles F coy Somrei post being led by myself along with the team of Kamjong District Police under the leadership of Addl SP Semmi Ramror, Inspt. Dependson A. Shimray (O.C. KKL-PS), S.I. L. Premkumar Singh (KKL-PS), H/C S. Somarendro Singh and PC Md Hanif Khan of Somrei Police Out-Post under the overall supervision of Ningam Siro, MPS, Superintendent of Police, Kamjong District, Manipur with necessary equipments including the source man rushed towards the eastern hill side of T. Natyang Village. On arrival at the eastern hill side of T. Natyang Village, searching the area in presence of the Gazetted Police Officer as witness Semmi Ramror, MPS, Addl SP Kamjong District the following items were recovered from the spot -

1. 12. 100 kgs of suspected brown sugar contained inside one yellow plastic sack marked as "TAJ CEMENT" including the weight of the container.
2. 9.100 kgs of suspected brown sugar contained inside one white plastic sack marked as "ROYAL CHEWING TOBACCO" including the weight of the container.
3. 14.500 kgs of suspected brown contained inside one plastic sack marked as "Hasina Manjayegee" mixed in colour including the weight of the container.
4. 14 kgs of suspected brown sugar contained inside one yellow plastic sack marked as "TAJ CEMENT" including the weight of the container.
5. 13 Kgs of suspected brown sugar contained inside one yellow plastic sack marked as "TAJ CEMENT" including the weight of the container
6. 11.200 kgs of suspected brown sugar contained inside one white plastic sack marked as "STAR CEMENT" including the weight of the container.
7. 13 500 kgs of suspected brown sugar contained inside one yellow plastic sack marked as "TAJ CEMENT" including the weight of the container
8. 26 5 litres of suspected Morphinated liquid contained in one water plastic bucket (brite) red in colour

All the above mention recovered items were seized by observing formalities on the same day i.e., 26/02/2021 at 08:30 a.m. However, the unknown accused persons were already absconded on seeing the police personnel.

Following the order passed by the Hon'ble Supreme Court of India vide Spl-C/ND7PS/2019/659-663 dated 26/11/2019 corresponding Cril Appeal No. 652 of 2012, (MANU/SC/00073/2016 (2016)3SCC379, the necessary procedure laid under ND & PS Act will be observed before the Hon'ble Magistrate

The seized items are being handed over to you for taking further necessary legal action.
