SUBJ : REPORT

1. Based on reliable inputs received through own sources regarding exfiltration of Manipur group cadres to Myanmar through Gen area Namlee an operation was planned to intercept and apprehend the exfiltrating cadres. Multiple MVCPs were launched on route Hongbei - Kasom Khullen - Bungdung at around 1545 hrs to intercept the exfiltrating cadres.
2. On 02 Nov 2023 at around 1830 hrs, the MVCP column at Nambashi Khullen intercepted a move of suspected individual moving on foot towards Bungdung from Nambashi Khullen on a foot track.
3. Upon questioning the individual was suspected and his presence in a Tangkhul dominated border village could not be justified. The apprehended individual was brought to COB Kasong for detailed questioning at 1900 hrs during which he revealed that he belongs to the banned outfit UNLF (P) bearing an army No. 2651 which was allotted to him during training at Kakching.
4. Details of apprehended individual is **Mr. Ningthoujam Sanjoy Meitei** aged 31 years s/o **Mr. Ningthoujam Shamu Meitei** r/o **Awang Potsangbam Khunao, Imphal East** Manipur, address as per Aadhar Card - **Waiton Makha Leikai, Waiton, Imphal East, Manipur - 795114.**
5. You are requested to lodge an FIR in this regard and book the individual as per the requisite law.
