Today i.e. 10/04/2022 at @ 9:00 am, received a reliable information that a powerful bomb likely IED was exploded near Namlee Village about 50 kms South from the Police Station. In this connection a Police team rushed to the spot for inspection to ascertain the fact. On spot inspection one tata truck bearing registration no. MN07C - 4180 was found completely damaged (front portion) due to the impact of the explosion, also found 28 fired (empty) cartridges and splinters of the bomb from the spot. On inquiry, it was suspected to be the handiwork of MNPF (A hill based UG group).

Hence, a case under FIR No. 6(4)2022 KKL-PS U/s 34/307/400/506/427 IPC, 25(1-C)A.Act & 3 Expl. Sub. Act have been registered for investigation under Suo-Moto.
