LODGING OF FIRST INFORMATION REPORT (FIR)

Sir.

On 17 April 2024, credible inputs received from own sources and other sister intelligence agencies regarding likely infiltration attempt by Valley Based Insurgent Groups (VBIGs) cadres near Indo-Myanmar Border, Columns of 8 Assam Rifles and 40 Assam Rifles were launched in an operation at 1000 hrs on 17 April 2024 in general area Makhlangkhong River corridor along Indo-Myanmar Berder. Own intelligence sources further confirmed infiltration of suspected individuals along Makhlangkhong River axis towards village Kangkum (Police Station- Kasom Khullen). After hot pursuit & on being challenged five suspected individuals (three VBIGs and two suspected NSCN(IM) cadres) were apprehended in gen area village Kangkum at approx 1800 hrs on 18 April 24 with cash amount of Rs. 1,86,720/- (Rupees one lakh eighty six thousand seven hundred twenty only). The apprehended VBIGs are active members of proscribed insurgent groups of KYKL & PREPAK. They are highly active & well trained cadres and are proficient in handling of various modern & sophisticated automatic weapons & explosives like AK 47, M-16. HK series weapons & Chinese Lathode gun, Improvised Explosive Devices (IED) & other war like stores. The VBIGs had infiltrated border with an intent to wage war against Govt of India, Two suspected NSCN (IM) cadres were also apprehended in the same vicinity who were providing food to VBIGs.
