- 1 On 21st Sep 08 an ambush party of 12 Assam Rifles of Kasom Post was deployed in Jor area track leading to TARET River from Namboshi Khullen in appropriate distance 3 km from Namboshi Khullen night.
- 2 While the ambush party in location on the night of 21st Sep-08 an unknown suspect aged approx 25/26 yrs. fired back two (2) rounds towards ambush party on being challenged by the ambush party at 2330 hrs same day.
- 3 The ambush party fired back at the unknown suspect and killed him on the spot.
- 4 The following arms and amm. recoveries were made:
 - (a) 01x Rifle with ledg. no. 07.3. OF- 014030
 - (b) 01x Magazine
 - (c) 08x Live ammunition
 - (d) 02x Empty box.
