This is to submit the enquiry report that has been endorsed to me from your good self office on 04/05/2022 for your kind perusal and further necessary action. Sir. this enquiry has been formally investigated by SI L. Rajesh Khuman .After he transferred from this PS, the same has been endorsed to me. I have examined the individual, namely, (1) Themreiyo Hungyo aged about 27 years S/o Ramyo Hungyo a resident of Tarong Village, P.O. - Yairipok, P.S. - Kasom Khullen & Dist. - Kamjong Manipur and (2) Remiso Ningshen aged about 32 years S/o (L) Kapangkhui Ningshen a resident of Nambashi Khunou village, P.O. - Yairipok, P.S. - Kasom Khullen & Dist. - Kamjong Manipur who are presently in Police remand in c/w FIR No. 6(12)2021 KKL- PS U/s 425/427/436 IPC & added section 400/384/34 IPC. On examination of the accused person namely Themreiyo Hungyo, he stated that, on 05/03/2022 at about 09:00 a.m. he had bought the Gelatin bomb and handed over to the accused person namely Remiso Ningshen. Then, the said incident (bomb blast) has happen along the NH - 102 near Nambashi Khunou by getting instruction from Mr. Chuirei Makung S/o Ngareishang Makung of Manthouram village. Kamjong District who is presently in judicial custody of the case FIR No. 6(12)2021 KKL- PS U/s 425/427/436 IPC & added section 400/384/34 IPC. On further examination of the accused person namely Remiso Ningshen, he also stated the same.

On minutely enquiring, it is revealed that, Mr. Chuirei Makung S/o Ngareishang Makung of Manthouram village, Kamjong District is the present Chairmen of MTRA and he had instructed to carry out the bomb blast along the NH – 102 near Nambashi Khunou Village by engaging Themreiyo Hungyo and Remiso Ningshen.

From the above facts, evidences and circumstances, it is ascertained that, Mr. Chuirei Makung is a member of gang and he performed many untoward incident at Public.

It is therefore, I am submitting the required report to you for favour of kind perusal and taking further necessary legal action please.
