





Sir,

I have the honour to state that , today i.e. 14/7/2022 at about 6:00 pm while I alongwith police team of Kasom Khullen Police Station under the supervision of Addl SP(Ops) Kamjong and the OC/KKL-PS, while conducting frisking and checking at NH-102-A near Hongbei village, 1(one) Tata Truck PC bearing Regd. No. MN 03T-1503 and 1(one) DI. bearing Regd.No. MN 05-2675 coming from Imphal towards Kasom Khullen were stopped for checking. While checking both the vehicles it was found loaded with 260(two hundred sixty) bags of Urea(Fertilizer) at Tata truck PC and 167(one hundred sixty seven) bags of Urea fertilizer at Tata DI. On verification Tata truck was driven by Phundreimayum Ajaman (20) yrs S/o Ph. Nahamcha r/o Heidrupokpi, PS- Yairipok, I/East, second driver Aslam Chesam(20)yrs s/o Tomba Chesam r/o Heidrupokpi, PS- Yairipok, I/East and the Tata DI was driven by Shamjetsabam Ibomcha(34) yrs S/o Sanjetsabam Itomcha, r/o Uchol Awang Leikai, PS- Andro, PO- Yairipok, I/East, second driver Dayananda Seleibam(28)yrs S/o Doren Seleibam, r/o Uchol Awang Leikai, PS- Andro, PO- Yairipok, I/East. On questioning both the drivers stated that they brought the Urea to deliver at Makan village for wrongful monetary gain without proper documents. Hence, seized the total 427(four hundred twenty seven) bags of Urea fertilizer alongwith both the transport vehicles and also arrested both the drivers alongwith second drivers. Hence the arrested 4(four) accused persons alongwith the seized articles are handed over to you for taking up further necessary legal action.
