Subject: Non-registration of FIR by Kakching Police Station despite written complaint - Request for urgent and concrete legal action, including arrest of the accused persons under applicable provisions of law.

Respected Madam.

I, Kh. Bidhyashwori, aged about 46 years, wife of Kh. Surchand Singh, resident of Pallel Maning Leikai. P.S. Pallel. District Kakching. Manipur, most respectfully submit this representation for your kind and immediate intervention.

On 4th October 2025, at around 5:30 p.m., my husband lodged a written complaint before the Officer-in-Charge, Kakching Police Station, against Mutum Surchandra Meitei, aged about 35 years, son of Mutum Chand Singh Meitei of Pallel Doctor Mamang Pareng Leikai, P.S. Kakching, District Kakching, Manipur, and his accomplices, namely Shri Chinglen (brother-in-law of Mutum Surchandra), Mutum (O) Sangita @ Inaocha, Mutum (O) Tombi Devi, Mutum Gourachandra, and others, for serious offences including physical assault, molestation with intent to outrage modesty, and attempt to murder.

However, despite submission of the said complaint, the police have failed to register an FIR or initiate any visible legal action against the accused persons till date.

Brief Facts of the Case:

On 4th October 2025, between 1:35 p.m. and 2:00 p.m., near Mutum Leirak Hedan Thapham, Pallel, Kakching District, adjacent to my homestead and the river, the aforesaid accused persons brutally attacked me after I requested them not to remove sand from the riverbed, which will be damaging our homestead land due to soil erosion caused by strong water currents.

During the assault:

Shri Chinglen forcefully twisted my right arm and molested me by deliberately touching my private parts. .

Mutum Surchandra Meitei struck my left ear and palm. and repeatedly hit me with a stone, causing profuse bleeding from my nose and face..

When I attempted to flee, Mutum Surchandra chased me with a sharp knife, intending to kill me.

My husband, who was nearby, rushed to rescue me but was also brutally assaulted by the accused persons and their associates, sustaining serious injuries..

Despite my injured condition, I reached Pallel Police Station and informed the police personnel of the incident and my husband's grievous condition. Shockingly, the police refused to take immediate action or register a case and instead directed me to go for treatment at a nearby medical centre, failing even to transport the injured to the hospital.

In a severely injured condition, I travelled by auto to Jivan Hospital, Kakching, reaching around 2:37 p.m., where I received emergency medical treatment. Doctors have confirmed injured in my right arm and facial bones, requiring major reconstructive surgery.

Further, Mutum (O) Tombi Devi and Mutum Gourachandra instigated the attack, shouting that I should be "taught a lesson and "my bones should be broken so I would never dare resist them again."

Issue:

Despite clear disclosure of serious cognizable offences under the Indian Penal Code. including for attempt to murder, outraging the modesty of a woman, grievous hurt, criminal intimidation and other relevant provisions, Kakching Police Station has failed to register an FIR or take any concrete legal action.

Such continued inaction constitutes gross dereliction of duty and violation of statutory obligations, while the accused persons continue to threaten and intimidate me and my husband, posing a grave threat to our lives and property.

2. Order prompt arrest of all accused persons to prevent tampering with evidence and further intimidation;
3. Ensure a fair, impartial, and time-bound investigation by an officer not attached to Kakching Police Station;
4. Initiate departmental proceedings against the police officials who failed to act on my husband's complaint;
5. Provide immediate police protection to me, my husband, and our family members;
6. Facilitate medical and witness protection support, as I continue to undergo treatment for my injuries and await major surgery.

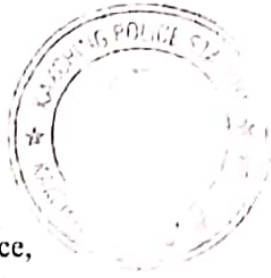
