

Subject: Submission of enquiry report in r/o GD No. 6/CCPS/2025 dated 13/08/2025, GD No. 13/CCPS/2025 dated 13/08/2025 and GD No. 4/CCPS/2025 dated 14/08/2025.

Sir,

With reference to the above-mentioned GD entries, I respectfully submit the enquiry report as follows. On 13/08/2025, one Joyson Kamei (48 years), S/o Kakandai Kamei of Nungba Village, Manipur, lodged a report that false, malicious and derogatory statements were being circulated in WhatsApp groups namely "Zeliangrong Dimki" and "Rongram Ngaek Dikho." In these groups, a post was uploaded calling late Haipei Rani Gaidinliu, an eminent Indian freedom fighter and recipient of the Padma Bhushan, a prostitute. The circulation was detected on 12/08/2025 at about 3:39 PM. Such deliberate defamation of a nationally revered figure has not only insulted her legacy but has also deeply hurt the sentiments of the community, the people of Manipur and the citizens of India at large. Copies of the screenshots of the posts were enclosed by the complainant.



On the same day, Smt. Chingdinliu Panmei, President of Rongmei Naga Luh-Phwam Manipur (RNLPM), submitted that derogatory and abusive messages against Rani Gaidinliu were also circulated on social media under the banner "Kukiland India." The messages described Rani Gaidinliu as a prostitute and used offensive terms like "Kacha Naga" and "landless Naga." The RNLPM expressed anguish, condemned the circulation of such defamatory messages, and demanded legal action against the culprits. Copies of the screenshots were also enclosed for reference.

Again, on 14/08/2025, Shri Meibon Phaomei, President of Zeliangrong United Committee, Manipur (ZUCM), submitted a complaint on behalf of the organisation stating that a post appeared on social media under the caption "Kukiland India – No Kacha Naga Hills in the World." The post contained baseless assertions regarding "Kuki Hills" in 1907 records and denied the existence of "Kacha Naga Hills." The post further carried derogatory statements calling Rani Gaidinliu a prostitute, which has high potential to incite unrest and provoke breach of peace. The ZUCM stated that such posts are provocative in nature and may disturb law and order in the State of Manipur, which is already reeling under ethnic tensions. They urged immediate legal action.

During enquiry, the complainants were examined and the screenshots of the alleged WhatsApp chats were verified. Some of the WhatsApp group members who had forwarded the message were examined in an attempt to trace the original uploader. It was further ascertained from one of the screenshots that the post had originally been uploaded in the WhatsApp group "NAGALAND NEWS TODAY" by one mobile number, i.e. +91-6909576108.

From the facts and circumstances revealed in the course of enquiry, it is evident that the false and derogatory information against a national freedom fighter was deliberately circulated through social media with malicious intent to defame her honour, provoke communal disharmony and breach of peace, and cause grave insult to the sentiments of her community and the Indian nation at large.

In light of the above, it is concluded that a cognizable offence has been committed. Therefore, all relevant documents, including the copies of GD entries, complaint petitions, and screenshots of the objectionable posts, are submitted herewith along with this enquiry report for favour of necessary legal action.




