Sir,

I have the honour to report that on 27/2/2025 I met one namely Chand Mohamad S/o Mohd. Saleem Alvi, permanent Address Noor Nagar, Puliya Transformer Wali gali, Khusal Colony, Meerut A/P Manipur. who is a religious priest that make offering for other devotees regarding welfare, in his Office located at Lamlong Bazar near Rural Bank for concerning my family problem. On which he told me that my family will face an ill fate in nearby future such as my son and myself will occur unnatural death. So to avoid the ill fate he has to perform a ritual prayer for my family, on which 400 gm of pure gold is necessary in the process. He told me to bring gold of 400 gm for performing the prayer. So on 28/2/2025 @10 am I went to his office for doing the prayer and handed over the gold to him which is amounting about Rs,40,00,000/- (Rupees forty lakhs) for the prayer. During the prayer he put the gold in a jar cover by a cloth and did his prayer. Then, he gave me the jar which is covered by the cloth and told me to open it the jar after a period of two days at my residence. And ill fate of my family will be overed. That, today i.e 2/3/2025 at @ 11.00am when I opened the jar it was found that some iron nails instead of the gold which had put earlier in the jar. When I called to his mobile no. i.e. 9258828510 and texting through WhatsApps for enquiry about the matter and he told me that he had not put the iron nails, it was the jar of other client which was mistakenly handed to me. But on asking him to return my gold, he had threatened me that not to call me again by threatening me that dire consequence will be met to me. It felt me that he had cheated me by taking advantage of my belief and thereby looting the said gold from me by way of acting as a priest.

It is, therefore, requested to kindly take up necessary action against the above noted persons as per law of the land.
