SI. Md. Riyajuddin of Porompat PS submitted an enquiry report with reference to RR No. 27/PRT-PS/2025, dated 18-02-2025 regarding complaint/report lodged by one Monoharmayum Barish Sharma, aged about 32 years, S/o Monoharmayum Balaraj Sharma of Wangkhei Ningthem Pukhri Mapal, Imphal East District, Manipur in c/w incident took place on 17-02-2025 at around 1:00 pm.

During enquiry, complainant was examined thoroughly. Also inspected where the incident was took place. On inspection, found some chairs were broken. Photographs were also taken for further reference. It is established that on 17th Feb, 2025 at around 1:00 pm, some female elders including unknown youths wearing sling bags (black in colour) stormed at the residential house of complainant and thereby resulting to damage of properties like plastic chairs. And those female elders including unknown youths were brought and led by one Sangeeta of Setupu Maning Leikai who identified herself as leader of Kumbi Apunba Meira Paibi. She instigated her followers and attacked the house of complainant. However, it was controlled by police personnel of Imphal East District. Over and above there is no report of physical assault on that day and there is no report of injury. And while examining the complainant, he did not disclose about the assault by the mob. Hence the case.


