Due to some problem, I was compelled to initiate for selling my Toyota Fortuner and accordingly, my daughter has uploaded to OLX for selling my vehicle on 10/02/2025. Thereafter, the accused person approached me with a proposal that he desired to purchase the said Vehicle and finally price for my vehicle has been settled at Rs. 21,00,000/- (Rupees twenty-one lakhs) only.
2. That, due to the present communal clash, the accused person proposed me for recording the said vehicle to his name before coming to Imphal for payment so that he would not have any problem to drive out from Imphal to Tripura. I have also believed that he would buy my vehicle as he has also deposited a sum of Rs. 25,000/- for changing of ownership of my vehicle to his name before the payment is made. Thereafter, according to his suggestion, No objection Certificate has also been sent to the accused person.
3. That, after changing the ownership of my Vehicle to his name as well as after sending NOC to the accused, he refused to purchase my vehicle and accordingly, I have requested the accused person I will bear all expenditure for flight from Tripura to Imphal and Imphal to Tripura for changing the ownership to my name again but he refused to come at Imphal. The accused person has breached my trust to him and as such, it will be appropriate to take a legal action for his crime.


