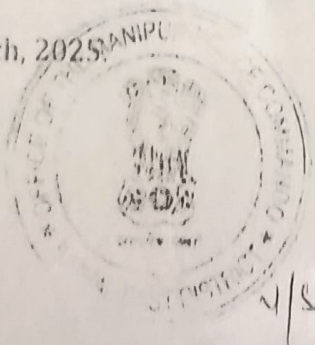
I have the honour to report today i.e. the 9<sup>th</sup> February, 2025 at about 6:00 a.m. received a reliable information about the presence of some extortionists at Hatta-Golapati, Imphal-East. Based on the said information, teams of CDO/IE Unit along with woman police personnel and a column of 4 AR under the command of Inspt. Kh. Henery Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted searched operation at Hatta-Golapati area, of Imphal East District.

In that one suspected woman coming from northern side was detained for verification. On verification, the detainee identified herself as one **Laiphrakpam Sophiya Devi @ Tombi @ Lamingbi** (24 years) D/o - **L. Kumar Singh of Moirang Ukilboard, Moirang PS, Bishnupur District, A/p -Golapati Masjid Achouba Awang Leirak, Porompat PS, Imphal East District.** On checking her belongings, one mobile phone, one wallet contain a sum of Rs. 260/- (two hundred sixty rupees) and a sum of Rs. 1, 07, 000/- (one lakh seven thousands rupees) in the denomination of Rs. 500 X 214 were found and recovered. On further verification, the detainee stated that she is an active member of the outlaw outfit NRFM (National Revolutionary Front of Manipur) joined through one Mr. Wangba of NRFM in the month of October, 2023 and presently working under his command. The arrestee stated that she was involved in extortion of money and recently, about a week before, on the advice of the said Mr. Wangba of NRFM, she had collected a sum of Rs. 50, 000/- (fifty thousand rupees) from an unknown person at Hatta near Minuthong, Imphal East District. She further stated that she had collected a huge amount of money from general public, govt. Officials, Schools and colleges etc. for raising their party fund.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Golapati Masjid Achouba Awang Leirak, Imphal East District at about 7:48 a.m. by observing all formalities and seized one mobile phone, a sum of Rs. 1, 07, 260/- (one lakh seven thousand two hundred and sixty rupees) and one wallet from her possession at 7:55 am. by observing due formalities from the spot i.e. Golapati Masjid Achouba Awang Leirak, near Community Hall, Imphal East District.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against her.


