Subj: Report.

Sir,

I have the honour to report that today i.e. 11th March, 2025 at about 2:00 p.m. received an information from a reliable source about presence of some cadres of the outlawed outfit KCP at Khurai Chingangbam Leikai, Imphal East District. Based on the said information, teams of CDO Imphal East Unit led by myself under the command of Insp. Z. Henry Singh, OC-CDO/IE Unit under the supervision of Shri. Y. Joyraj Singh, MP's Addl. SP(Ops)/IE rushed to the said area and conducted a search operation at Khurai Chingangbam Leikai, Imphal East District at 2:30 p.m.

In that, two unknown suspected persons were detained for verification and checking. On verification, the detainee identified themselves as; **Khongbantabam Nanao Meitei @ Khanganba (25 years) S/o (Late) Kh. Mabintho Meitei of Nongada Shantipur, Lamlai PS, Imphal East District, Manipur and Kshetrimayum Roshan Singh @ Kaler (25 years) S/o Ksh. Naobi Singh of Mayang Langjing Tamang, Lamshang PS, Imphal West District an active cadres of the outfit KCP (PWG).** On checking their bodies, two nos. of mobile phones and one wallet were found and recovered.

On verification of the first detainee, Khongbantabam Nanao Meitei, he stated that he joined the said outfit in the June, 2024 through one Mr. Ajit of KCP (PWG) and got his basic military training for 45 days in the same year under the command of one Mr. Pari of KCP (PWG) and presently working under the command of one Mr. Salaitaret of KCP (PWG).

On verification of the second detainee, Kshetrimayum Roshan Singh, he stated that he joined the said outfit KCP (PWG) group in the month of June, 2023 through one Mr. Ibungo Ngangom and presently working under the command of the said Mr. Salaitaret of KCP (PWG). He further stated that he is a former cadre of the outlaw outfit UNLF and got his basic military training in UNLF under the command of one s/s - Captain Khurou Ngangom of UNLF with allotted army no. 3636 of 55th batched.

In light of the above facts and circumstances, both the detainees were arrested from the spot i.e. Khurai Chingangbam Leikai near DDK Imphal Gate, Imphal East District at 3:02 p.m. by observing due formalities.

One mobile phone (Redmi A3) bearing IMEI no. 86856597334540 & 86856597334541 along with one Airtel SIM card no. 8991160990026207646U was seized from the possession of the arrestee **Khongbantabam Nanao Meitei** at about 2:10 p.m. from the spot i.e. Khurai Chingangbam Leikai near DDK Imphal Gate, Imphal East District by observing due formalities.

From the possession of the arrestee **Kshetrimayum Roshan Singh**, one mobile phone (Iphone 13) bearing IMEI no. 350024068039292 & 350024068087481 along with one Airtel SIM card bearing no. 89912657244440110220 and one wallet containing one AADHAR card and a sum of Rs. 130/- (one hundred and thirty rupees) were seized from the spot i.e. spot i.e. Khurai Chingangbam Leikai near DDK Imphal Gate, Imphal East District at about 2:15 p.m. by observing due formalities. On further verification of the detainees, both the detainees stated that they were involved in extortion of money from the general public for raising their party fund.

Thereafter, the arrested persons along with the seized mobile phones are being handed over to you for taking up further necessary legal procedures against them.


