Heisnam Linthoi Devi (15) yrs D/o H. Bigyananda of Nongmakhong Makhia Leikai, Bishnupur District, and 3). Sagolsem Landhoni Devi (17) yrs D/o S. Lukhoi of Samram Mayal Leikai, Thoubal District. On preliminary enquiry they stated that one unknown person who is suspected to be a member of KYKL/Sorepa contacted them to joined the banned outfit through telephone. So, they were rescue from joining the banned outfit by the police.

Hence a suo mutuo case under FIR No. 60(03)2025 PRT-PS u/s 143 BNS-2023 & 18(B)/20UA(P)Act. is registered for investigation.


