Sir,

I have the honour to report that today i.e 22/3/2025 at 11.30 am while I was inspecting the PO i.e. Korepai Chingabam Leikai in c/w case FIR No. 63(3)2025 PRT-PS u/s 109/117(2)/3(5) SNS 2023 and 25(7) A.A. Act and 20 UA(P)Act. I received an information about the presence of some accused persons at the camp of Arambai Tenggol Unit-17 Community Hall, Khurai Lainingthou Puthiba. Immediately, I along with Police team of Porompat PS assist by ASI. Md. Abdul Farooque including CDO-IE and 4 AR rushed to the said area/ location and raided, in which the following items i.e. 1) 4(Four) Nos. of Hunting Boot, 2) 1(One) No. of Helmet green in color, 3) 2(Two) Nos. of BP- Jacket (i.e. one black color and one green color), 4) 1(One) Camo Pithu bag, 5) 5(Five) Nos. of Rifle-Selling, 6) 3(Three) Nos. of Belt (i.e. 2(Two) black in color and 1(One) green color), 7) 8(Eight) Nos. of BP-iron plat, 8) 2(Two) Nos. of BP-Fiber plat, 9) 2(two) nos. of Holster, 10) 1(One) no. of Redmi mobile phone dark grey in color, 11) 1(One) no. of 9mm magazine pouch, 12) 3(Three) nos. of wacky talkie, 13) 4(four) nos. of wacky talkie Charger, 14) 1(One) no. of Tear gas smoke shell, 15) 1(One) no. of gun Bayonet for INSAS Rifle, 16) 2(Two) nos. of gun Bayonet for 303 Rifle, 17) 2(Two) nos. of sword, 18) 2(Two) Nos. of stallion box, 19) 2(two) nos. of pair knee cap, 20) 1(One) no. of magazine pouch, 21) 2(Two) nos. of big banner of AT-Unit-17, and 22) 8(eight) nos. of camo-T-Shirt (i.e. 7- nos. of full camo T-Shirt, and 1(one) no. of half camo T-Shirt, 23) 4(Four) nos. of long pants, and 3(Three) nos. of camo full shirt, 24) 3(Three) nos. of military jacket, 25) 1(one) no. of four wheeler gypsy without Regd. No., 26) 1(one) no. of four wheeler Scorpion without Regd. No. and 27) 103(one hundred zero three) nos. of empty cartridge and 1(one) live round of 9mm ammunition were found and seized from the spot by preparing formal seizure memo at 3.55 pm.

On further searching, the following articles i.e. 1) 5(five) nos. of live rounds of suspected to be barrel-Gun, 2) 1(One) no. spring of assault Rifle are found from the spot and the same was seized by observing formal seizure memo at 4.58 pm.

The following items were also found on searching i.e. 1) One cap grey color suspected to be containing heroin No. 4 powder (weighing 12.23 grams) 2) 24 (Twenty four) nos. of Veils containing powder suspected to be heroin no. 4 (weighing 29.69 grams including the weight of veils), 3) 73 (Seventy three) nos. of empty veils, 4) One smart cart RC-Book of 2- wheeler TVS having Regd. No. MN06SG-0418 in the name of one Suraj Rimal and 5) Some documents viz :- i) Head letter of "Arambai Tenggol" ii) One diary marked as "Executive diary-24" and iii) one Note book marked as "Fortune", were also seized from the spot in presence of executive magistrate Imphal East namely N. Ratan Singh SDC Heingang and the same were seized by observing proper seizure memo at 5.59 pm, however there was no any member are present at the time of raid.

It is, therefore, I have handed over all the seized articles to you for kind perusal and necessary action.
