Subject : Report.

Sir,

I have the honour to report that today i.e. the 25th March, 2025 at about 1:30 p.m. received a reliable information from our own intelligence about the concealment of a large nos. of arms and ammunitions at Chingkhei Ching, Imphal-East District. Based on the said information, a combined team of CDO/IE Unit, 29 Bn. BSF and 164 Bn. BSF under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP (Ops) Imphal East District conducted a searched operation at Chingkhei Ching, and its adjoining foothills areas of Imphal-East District at about 2:00 p.m.

During the search operation, two nos. of sack bags were found lying abandoned at the western side of the foothill of Chingkhei Ching, Imphal East District. On opening the sack bags, the under noted arms, ammunitions and explosives were found and recovered ;

- i. 1(one) no. of 9 mm Pistol with magazine,
- ii. 1(one) no. of local made Automatic gun
- iii. 3(three) nos. of No. 36 Hand Grenade with 9 (nine) nos. of detonator,
- iv. 1(one) no. of 303 LMG magazine,
- v. 144(one hundred forty-four) nos. of 5.56 live ammunitions,
- vi. 6(six) nos. of 303 live ammunitions,
- vii. 3(three) nos. of 9mm live ammunition,
- viii. 2(two) nos. of 5.56 INSAS LMG magazine,
- ix. 1(one) no. of 5.56 INSAS Rifle magazine,
- x. 1(one) no. of Radio set,
- xi. 2(two) nos. of BP Helmet,
- xii. 2(two) nos. of BP Jacket,
- xiii. 10 (ten) nos. of Anti Riot shell,
- xiv. 1(one) no. of blank cartridge,
- xv. 1(one) no. of Empty ammunition box,
- xvi. 2(two) nos. of sack bag and
- xvii. 5 (five) nos. of Tube launching.

Accordingly, the said abandoned arms, ammunitions, explosives along with the sack bags were seized at 2:21 p.m. from the foothill of Chingkhei Ching, western side, Imphal-East District by observing due formalities.

Therefore, the seized arms, ammunitions and explosives are being handed over to you for taking up further necessary legal procedures.
