Sir,

I have the honour to report that today i.e. the 11th April, 2025 at about 12:02 a.m. based on a credible information from 4 AR corroborated with our own intelligence, about the presence of some active members of the outlawed outfit KCP (Noyon) at Checkon area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 4 AR under the command of Inspt. Kh. Henry Singh, OC CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Atdl. SP(Ops) Imphal East rushed to the said area and conducted a random frisking and checking to the suspected passersby.

In that, one suspected person was detained for checking and verification. On checking the detainee body, one wallet and two nos. of mobile phones were found and recovered from his possession. On verification, the detainee identified himself as one Huidrom Sunder Singh @ Sanathoi @ Salai (39 years) S/o H. Shamu Singh of Sekta Awang Leikai, Lamtai PS, Imphal East District A/p - New-Checkon Tribal Market, Imphal East. On further verification, the detainee stated that he is an active member of the outfit KCP (Noyon) joined through one Mr. Bobby @ Pamel of KCP (Noyon) in the month of August, 2023 and presently working under his command. He further stated that recently in the month of January, 2025, he had handed over one 9 mm Pistol loaded with two live rounds in the magazine to one unknown person sent by the said Mr. Bobby. The detainee further stated that, on the advice of the said Mr. Bobby of KCP (Noyon) he had extorted a huge amount of money from various shops located at Mantripukhri area for raising their funds.

So, the detainee was arrested from the spot i.e. Checkon crossing near Traffic Island at 12:30 a.m., and seized; (i) one wallet containing a sum of Rs. 400/- (four hundred rupees) and one AADHAR card, (ii) one mobile phone (Nokia TA-1174) bearing IMEI No. 353111115661439 & 353111115661444 along with one Airtel SIM card bearing no. 899116099003477318U and (iii) one mobile phone (Redmi Note 13 Pro) bearing IMEI No. 864698062156100 & 864698062156118 along with two SIM card bearing no. Airtel - 8991160990023849130 U & Jio - 89918650400301961134 from his possession at 12:35 a.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
