Sir,

I have the honour to state that today i.e. 07/10/2025 @ 8:30 am, while conducting a random frisking and checking along NH-2 at Kabinam village about 4 Kms South of Maram PS by a joint team of Senapati Police (Special Operation Team) and QAT B-109 Bn. CRPF. While frisking and checking, one vehicle Wagon-R Red in colour bearing Reg. No. DL8CP-7014 was seen coming from Senapati side towards Mao, The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as M Leo Shiru (26) s/o Moses of Tusii Nganii Khumai, Senapati, Senapati-PS, Senapati District Manipur accompany by Thaongao Ruben (28) yrs s/o Ruben of Phaibung Khunou, Phaibung –PS. Senapati District. On checking the vehicle suspected to be brown sugar was found concealed under the dashboard of the vehicle. As such DC/SPT was intimated by my senior officer and a request was made to depute one



Magistrate. Accordingly, SDC/SPT Panii Ngaonii (Executive Magistrate), of Senapati was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence the said driver namely M Leo Shiru (26) o Moses of Tusii Nganii Khumai, Senapati, Senapati-PS, Senapati District Manipur and Thaongao Ruben (28) yrs s/o Ruben of Phaibung Khunou, Phaibung -PS, Senapati District, Manipur, the vehicle was thoroughly checked. On checking, 10 (Ten) soap cases of suspected to be brown sugar were found concealed under the dashboard of the vehicle.

The 10 (Ten) soap cases suspected to be brown sugar were weighed by using weighing machine in the presence of the Executive Magistrate and witnesses and weighed 117 grms. (including the weight of small transparent plastic). The approximate value is Rs. 1,17,000/- (One lakh seventeen thousand). The 10 (Ten) soap cases of suspected to be brown sugar were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure memo. The detained persons namely M Leo Shiru (26) s/o Moses of Tusii Nganii Khumai, Senapati, Senapati-PS, Senapati District Manipur and Thaongao Ruben (28) yrs s/o Ruben of Phaibung Khunou, Phaibung -PS, Senapati District, Manipur was formally arrested by observing formalities at 8:40 am. During the seizure and arrest, videos or photos was not uploaded in eSakshya as I don't have an authorized eSakshya account. However, I have recorded the video of the seizure and arrest in the phone.
