On receiving the information, a joint team of Commando Unit Thoubal led by Shri K Nitaranjan Singh OC/CDO Unit Thoubal under the supervision of Shri HijamDevendra Singh, MPS: Addl. SP(Ops)/Thoubal and under the overall supervision of SP/Thoubal District rushed to the Phoudel area at around 06:30 p.m. and conducted frisking and checking of suspected persons. In that, one unknown person was found with one Royal Enfield in a very suspicious nature (.) Upon seeing the police team, the rider attempted to evade the police, lost control, dropped the bike, and was subsequently apprehended and detained for spot verification. On preliminary verification, he identified himself as Phundreimayum Dawad Khan (24 yrs. S/o (L) Ph. Rafijuddin of Sangaiyumpham Part-I, Puleipokpi Salam Macha, a gang member of vehicle lifter. Further disclosed that he, in association with one Md. Nitarnan Singh, OC, CDO Unit, TBL and a column of 4 AR immediately rushed to Lilong Tharaorok area at around 11:25 a.m. and conducted frisking and checking of suspected persons. In that, one unknown person was seen standing near Lilong Tharaorok waiting shed in a very suspicious manner. On his suspicious nature, he was detained for verification. On preliminary verification he identified himself as Konjengbam Orbit Singh @ Naotomba 26 yrs. S/o. (L) K. Inaocha Singh of Langthabal Kunja Awang Leikai an active member of KCP(PWG) a banned unlawful organization. On spot verification, he disclosed that he joined KCP(PWG) in the 2023 through one Mr. Sanamacha of same organization. He got 45 days basic military training at Kangchup. After completion of training he was posted at Heirolk. He is working under the command of Khaba @ Amitab of KCP(PWG). Hence, he was arrested at 11.40 a.m. of 04/09/2025 from Lilong Tharaorok near waiting shed by observing formalities. Hence the case.	-	-	-

Suresh Singh received a reliable information by safe/tbl (special action force for extortion) that some active cadres of KCP(PWG), a banned unlawful organisation are loitering in and around Thoubal area for prejudicial activities like extortion, monetary demand, threat & kidnapping. Acting on the information, organised a joint team of CDO unit Thoubal led by Inspt. K. Nitarnan Singh, OC CDO unit, Thoubal under the supervision of Addl. sp(ops) Thoubal and under the overall supervision of SP/Thoubal District and a column of 33 AR immediately rushed to opposite district hospital, Thoubal gate area at around 05:30 p.m. and conducted frisking and checking of suspected persons.
