Matter: - On 2/10/2025 at around 1700 hrs, a suspected member of armed cadre was travelling towards Myanmar. The vehicle was stopped near mobile vehicle check post (MVCP) of 8 Assam Riffle 1 km short of Chassad. While inquiry the individual shawn suspected behaviour and was asked about his identity. On being failed to prove the identity, the indls was taken for further questioning. Considering the attack on 33 Assam Rifle convoy on 19th Sept. 2025, it was considered to further question the indl. On questioning the invl. Accepted that he is a cadre of People Liberation Army (PLA). There all certain suspected photograph were found in his phone which shows the invl. Is involved in anti-national activities. The invl. Accepted that he is residence of a village khurai Imphal East. He also accepted that he is currently leaving in his relative house in ukhrul. He told that wpns are present in a garden in his relative house in Ukhrul. The 8 Assam rifle team asserted the invl. Recovered. After that invl. Told that wpns. are hiding in Imphal. The invl. was taken by guard party to Imphal, however, enroute he denied to give location of wpns. The invl. was taken to SSP office in Imphal at 1630 hrs on 3rd Oct. 2025 where he was inguired by police officers. The invl. toll that he is cadre of UNLF however was not able to give any evidence or service number for same. It is suspected that invl. is hard core cadre of People Liberation Army (PLA) and engage in serious anti national activities. Hence it is requested to pls regular an FIR at earliest to prevent further anti national activities. The mobile of above invl. is sent for forensic analysis by security forces and well be handed over tomorrow. Hence the case.
