

For better appreciation of your good-self a photograph taken from the Google Map spotting the illegal constructions of structures, a photograph taken through GPS Mapping camera spotting the illegal constructions of structure and the field elevation and a printed 10 (ten) numbers of copy of photographs take through GPS Mapping camera are annexed herein below.

That the acts of the unknown group of individual are liable to be tried for criminally trespassing and causing illegal constructions inside the Complainants' private patta land. In fact whoever causing the illegal construction is taking an undue advantage of the present ongoing conflict situation in the State of Manipur.

That due to the present ongoing conflict situation prevailing in the State of Manipur the complainants are unable to visit Jiribam Police Station for filing a Complaint before the O.C. Jiribam P.S. in connection with the aforementioned facts and circumstances as such the complainants are placing the present complaint before your good self for causing investigation so as to prevail the rule of law.

That the complainants humbly submitted that the above mentioned facts and circumstances have made out a prima facie case having criminal in nature so that a police investigation can be carried out. Since no one came out claiming a title and ownership or any kind of legal interest with respect to the private patta land of the complainants there is absence of inclining the present case into a civil nature, or otherwise if it does so a civil suit might have been filed.

In view of the facts and circumstances mentioned above, it is, therefore, humbly prayed that your good-self may be pleased to register the present complaint a zero FIR and be proceeded the needful in the interest of justice and also to prevail the rule of law.



That on 20th March, 2025 the complainants came to know that some unknown group of individuals have illegally caused construction of 3 (three) numbers of pacca structures having brick walls and tin-sheet roofing, 1 (one) numbers of Temporary shed with tin sheet roofing meant for masons and labourers dwelling and go-down for keeping construction materials, Swimming pool, a rectangular shape concretized foundation structure, excavation of field/ground on the southern portion within the aforementioned private owned patta land of the complainants without the knowledge of the complainants.

4. That in order to know exactly what was going on over the said land and who were involved in the said illegal construction by criminally trespassing inside the private patta land the complainants through their counsel filed an application dated 24th March, 2025, under RTI Act, 2005, before Public Information Officer, Jiribam District, seeking information as to whether the State or District authority has caused the said illegal construction but in reply to the same it was informed that the neither the State nor the District have done any type of construction inside the said land.
