

About the subject noted above, I would like to inform your esteemed office regarding the fear and apprehension me, that my family members have been undergoing for the last few months due to threats and intimidation.

In the month of March 25, I was called at Khurai Bazaar by an unidentified person on the pretext of discussing some matter. However, on reaching the location and meeting the person, I was threatened and intimidated to back out from our family dispute. Till date, we have been ignoring the issue despite getting many such threats and intimidation from various unidentified persons and sources.

However, on 18 June 25 at around 17:00 hrs approx, the situation was very alarming and disturbing, causing panic amongst my family members as 04 unidentified persons seem to be having arms although not displayed openly entered my courtyard and was knocking at my residence doors. The unidentified person came to my House in a white Gypsy without any registration number. With God's grace, nobody was present at my house at that time however, the body language was very aggressive and threatening. CCTV footage is submitted along with the complaint letter for your perusal.

Although I am presently undergoing treatment outside Manipur however due to prevailing situation, I am very apprehensive about my family's safety. At present, I am safe, but I am very apprehensive about my own safety when I return to my home state.

Please investigate the imminent threat on an urgent basis.



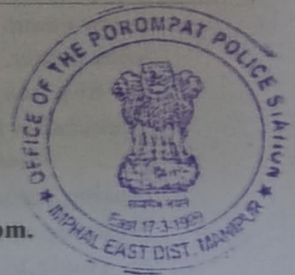
