

I have the honour to report that today i.e. the 1<sup>st</sup> July, 2025 at about 1:00 p.m. received a reliable information from our own source about the presence of an active member of the outfit KCP at Khurai, Imphal East District. Based on the said information, teams of CDO/IE Unit rushed to the said area and conducted a searched operation at Khurai Chaithabi Leirak, Imphal East under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Ak Sadananda Singh, MPS, in charge Addl. SP(Ops)IE.

In that, one suspicious unknown person was detained for spot verification at Khurai Chaithabi Leirak near SAIBO Hospital, Imphal East District. On checking one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one **Md. Ajad Khan @ Kathokpa (29 years) S/o Md. Ali of Khabeisoi Sabal Leikai, Heingang PS, Imphal East**. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) group joined through one Mr. Amit of KCP (PWG) in the month of July, 2024 and got his basic military training for 15 days under the command of Mr. Baonao and Mr. Naoboi at Thanga Karang, Bishnupur District. The detainee further stated that he is presently holding the rank of s/s - Private and working under the command of one s/s - Project Officer Mr. Langamba of KCP (PWG).

So, the detainee was arrested from the spot i.e. Khurai Chaithabi Leirak near SAIBO Hospital, Imphal East District at 1:20 p.m. and seized one mobile phone (Redmi 14C 5G) bearing IMEI no. 861608075133841 & 861608075133558 along with one Jio SIM card bearing no. 70055736310 from his possession at the spot i.e. Khurai Chaithabi Leirak near SAIBO Hospital, Imphal East District at 1:25 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.

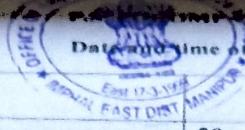
