I the undersigned have the honour to report that I have been living at Zou Veng, Churachandpur since 15/20 year. That, on 03/05/2023 my house located at Zou Veng is looting, ransacking and burnt down of my house by Kuki militants. In this regard, the following items i.e. furniture items, wooden plank, door, windows, 2- Two wheelers vehicle, Grossery items and also all the household items are burnt down and looted from my house. The total value of burnt down and looted items are Rs. 15,00,000/- (Fifteen Lakh) approximately. That, I couldn't report in time as I was engaged in family matter.

It is, therefore, requested to kindly take up necessary legal action against the Kuki militants according to law.


