

...had been kidnapped and a ransom was demanded for his release. Upon receiving the news, he immediately tried to contact his son on his mobile number, but the phone was found to be switched off. He then contacted his family members and sought help in tracing his son's whereabouts. Meanwhile, five persons from my locality, namely (i) Aribam Aziz, (ii) Yumkhalbam Najakat, (iii) Tholcha @ Sajish, (iv) Aribam Tomba, and (v) Yumkhalbam Helal came to his residence and informed him they had heard about the abduction of his son by some unknown persons. They assured him that they would help in securing his release. He requested them to extend their help. On the same day, at around 11:30 PM, the aforementioned individuals came to his house again and told me that he must arrange Rs. 2,00,000/- (Rupees Two Lakhs only) for my son's release. Since he could only arrange Rs. 1,00,000/- (Rupees One Lakh only) at that time, he handed over the said amount to them. They then left with the money. On the next day, i.e., 9th August 2024 at around 03:00 AM, his son was released by the unknown kidnappers. However, the same group of individuals again approached me and informed me that he needed to arrange an additional Rs. 1,00,000/- (Rupees One Lakh only) for the release of his son's motorcycle-a Yamaha R15, he arranged the amount and handed it over to them. Later, the motorcycle was returned to me. However, my son's mobile phone an Apple iPhone 14, white in colour remained with the kidnappers. Due to fear and mental distress, he did not report the matter immediately to the authorities on time. Hence the report


